CONDITIONS OF MEMBERSHIP

By signing the form overleaf you indicate your acceptance and agree to these terms and conditions.

i. As a condition of joining The Militias of Anglia and the larger world of re-enactment I hereby acknowledge that the activities of The Militias can be potentially dangerous and that I voluntarily accept any risks attendant upon the association's activities. I agree to be bound by the rules of the Association and not to hold the group, or the organisers of any event, responsible for any loss or injury that I may suffer whilst attending any of its activities, howsoever caused.

ii. I enclose the subscription (renewable by 30th March annually). I understand to be covered by insurance that I must join The Militias of Anglia and to also pay a Regimental subscription (it can be temporary) of any regiment if taken to them or any society that requires same and they have rules which state as guests we need to be temporary members for their insurance purposes. (Payment should be made as directed by any Commanding Officer if we are joining an outside organised event or the association's Membership Secretary

iii. I understand that all applications are subject to ratification by the Committee (the governing body of The Militias of Anglia).

iv. I understand that only current members may attend the Militia's events or training events. (Possession of a signed current membership card is regarded as proof of membership).

v. I understand that Militia's privacy notice can be requested which explains how my personal data is handled. If I prefer a printed version then I can contact the committee or one can be made available to me by prior arrangement from an event's Welcome Tent.

vi. Notwithstanding any permit or licence to possess explosives, I undertake not to bring any explosives or propellants to events nor to remove them from events without prior arrangement with the event powder officer, and not to keep any explosives or propellants outside an official store overnight.

vii. Electronic version of this form will be accepted without a signature, as agreed by the Committee, so long as it instead contains a completed positive consent tick box re personal data.
